We wish to inform you that the Corporate Insolvency Resolution Process (CIRP) of Vasan Health Care Private Ltd. was successfully concluded upon issuance of Order dated 3rd February 2023 by the Hon'ble National Company Law Tribunal, Chennai (NCLT) approving the resolution plan submitted by ASG Hospital Private Ltd., Jodhpur (ASG). A copy of the said order has been posted on the website of the company at "www.vasaneye.com" under the Tab "CIRP".

As per the NCLT approval order, a Monitoring Committee was formed for implementation of the resolution plan. Representatives of ASG, representatives of Committee of Creditors and the erstwhile Resolution Professional are the members of the Monitoring Committee. The erstwhile director(s) of the company have vacated their office from the date of approval of the resolution plan by NCLT. The stakeholders have been informed of the abovesaid developments through various communications which have been placed in the website of the company referred above.

The Monitoring Committee is overseeing the implementation of the resolution plan as per the terms of the NCLT approval order in relation to distribution of the resolution plan amount, facilitating filing of necessary returns and other compliances like extinguishment of share capital, issuance of fresh equity shares, satisfaction of charges, merger, handing over of documents, etc. Upon completion of its role, the Monitoring Committee shall be disbanded and an implementation report shall be filed with NCLT.

While we express our gratitude to all the stakeholders for their kind cooperation during the CIRP period, they are hereby advised to take due note of change in management in terms of the NCLT approval order of 3rd February 2023 and that the new management, ie. ASG Hospital Private Ltd. has fully taken over the management and control of Vasan Health Care Private Ltd.
